**RESOLUTION ADOPTING AND AUTHORIZING AN AMENDED
 B.G. TRANSIT DRUG AND ALCOHOL TESTING POLICY**

WHEREAS, the City of Bowling Green receives state and federal funding annually from the Ohio Department of Transportation (ODOT) to provide public transportation to citizens; and

WHEREAS, a Drug and Alcohol Testing Policy is required for transit systems funded by the Ohio Department of Transportation (ODOT) and the Federal Transit Administration (FTA); and

WHEREAS, a B.G. Transit Drug and Alcohol Testing Policy was adopted by Council on January 7, 2008;

WHEREAS, the Ohio Department of Transportation (ODOT) recently announced that certain provisions of its drug and alcohol testing procedures (49 CFR Part 40) have been amended and that ODOT requires these amendments also be incorporated at the local level; and

WHEREAS, the amendments to the B.G. Transit Drug and Alcohol Testing Policy were prepared in accordance with applicable federal requirements; and

NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF BOWLING GREEN, OHIO:


SECTION 1: The Council does hereby approve the proposed amendments to the B.G. Transit Drug and Alcohol Testing Policy.

SECTION 2: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this resolution were adopted in an open meeting of the Council, and that all deliberations of this Council and any of its committees that resulted in such formal actions were in meetings open to the public in compliance with all legal requirements.


SECTION 3: This resolution shall take effect at the earliest time permitted by law.


