WHEREAS, each jurisdiction receiving said grant funds must adopt a citizen participation plan that sets forth the jurisdiction's policies and procedures for citizen participation.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF BOWLING GREEN, OHIO:

SECTION 1: The City of Bowling Green adopts amendments to the foregoing Community Development Block Grant Citizen Participation Plan which was available for public review and comment February 15 through March 4, 2013.
