
**ORDINANCE ACCEPTING A DEED FROM



**ORDINANCE AUTHORIZING THE UTILITIES DIRECTOR
TO ENTER INTO AN AGREEMENT WITH INTERSTATE
GAS SUPPLY TO PROVIDE A FIXED PRICE OPTION TO
MUNICIPAL NATURAL GAS AGGREGATION CUSTOMERS,
AND DECLARING AN EMERGENCY**

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BOWLING GREEN, OHIO, COUNTY OF WOOD, STATE OF OHIO:

SECTION 1: That the Utilities Director is hereby authorized to enter into a contract or contracts with Interstate Gas Supply to provide a fixed price option to municipal natural gas aggregation customers.

SECTION 2: This ordinance shall take effect as an emergency measure. The reason for the emergency is the prompt effectiveness of this measure is necessary in order to assure a continuous and uninterrupted supply of natural gas for our customers, and thereby protect the public health, safety and well-being of our citizens.
