**ORDINANCE AUTHORIZING THE UTILITIES DIRECTOR TO EXECUTE A COOPERATIVE AGREEMENT BETWEEN NORTHWESTERN WATER AND SEWER DISTRICT, THE CITY OF PERRYSBURG, AND THE CITY OF BOWLING GREEN, AND TO MAKE APPLICATION FOR A LOCAL GOVERNMENT INNOVATION FUND GRANT TO CONDUCT A FEASIBILITY STUDY FOR AN EMERGENCY WATER INTERCONNECTION BETWEEN THE CITY OF TOLEDO AND THE CITY OF BOWLING GREEN WATER SYSTEMS, AND DECLARING AN EMERGENCY**

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BOWLING GREEN, COUNTY OF WOOD, STATE OF OHIO:

SECTION 1: That the Utilities Director is hereby authorized to execute a Cooperative Agreement between the Northwestern Water and Sewer District, the City of Perrysburg, and the City of Bowling Green, and to make application for a Local Government Innovation Fund Grant to conduct a feasibility study for an emergency water interconnection between the City of Toledo and the City of Bowling Green water systems.






WHEREAS, representatives of the City of Bowling Green and representatives of the Bowling Green Municipal Employees Association (BGMEA), have negotiated a contract; and


