**ORDINANCE AUTHORIZING THE UTILITIES DIRECTOR  
TO SIGN A CONTRACT TO PARTICIPATE IN THE  
AMP DEMAND RESPONSE PROGRAM,  
AND DECLARING AN EMERGENCY**

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BOWLING GREEN, COUNTY OF WOOD, AND STATE OF OHIO:

SECTION 1: That the Utilities Director is hereby authorized to sign a contract to participate in the AMP Demand Response Program, in substantial accordance with the exhibit attached hereto and made a part hereof.

SECTION 2: This ordinance shall take effect as an emergency measure. The reason for the emergency is the prompt effectiveness of this measure is necessary in order to have sufficient time to enroll customers in the program before the May 1, 2014 deadline, and thereby protect the public health, safety and well-being of our citizens.


