**ORDINANCE AMENDING AND ADOPTING  
SECTION 150.30 OF THE CODIFIED ORDINANCES  
OF THE CITY OF BOWLING GREEN, OHIO, CONCERNING  
THE B-3 CENTRAL BUSINESS DISTRICT  
ZONING CLASSIFICATION**

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BOWLING GREEN, COUNTY OF WOOD, AND STATE OF OHIO:

SECTION 1: That Section 150.30 of the Codified Ordinances of the City of Bowling Green, Ohio is hereby amended and adopted to read as follows:

- (D) Prohibited Uses: Notwithstanding any other provision herein, no ground floor area of structures located within the B-3 District shall be used for residential purposes, as all residential uses shall be restricted to the second floor and above in this District.

SECTION 2: This ordinance shall take effect at the earliest time permitted by law.
