**ORDINANCE AUTHORIZING THE MUNICIPAL ADMINISTRATOR
TO SIGN A CONTRACT WITH THE BOWLING GREEN
EMPLOYEES ORGANIZATION (B GEO),
AND DECLARING AN EMERGENCY**

WHEREAS, representatives of the City of Bowling Green and representatives of the Bowling Green Employees Organization have negotiated a contract, and

WHEREAS, the Bowling Green Employees Organization has ratified said contract.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BOWLING GREEN, OHIO:

SECTION 1: The Municipal Administrator is hereby authorized to sign and enter into a contract with the Bowling Green Employees Organization said contract being on file in the Personnel Department of the City of Bowling Green.

SECTION 2: The ordinance shall take effect as an emergency measure. The reason for the emergency is that the prompt implementation of said contract is necessary in order to maintain continuity with Bowling Green Employees Organization, and in that manner protect the public health, safety, and welfare of our citizens.


**ORDINANCE AUTHORIZING THE PURCHASE OF THE
FORMER RIDGE STREET SCHOOL PROPERTY
GENERALLY KNOWN AS 225 RIDGE STREET,
BOWLING GREEN, WOOD COUNTY, OHIO,
AND DECLARING AN EMERGENCY**


BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BOWLING GREEN, COUNTY OF WOOD, STATE OF OHIO:

SECTION 1: That the Mayor of the City of Bowling Green, Ohio, is hereby authorized to complete the contract entered into on June 10, 2014, to complete the purchase of the former Ridge Street school property, generally known as 225 Ridge Street, Bowling Green, Ohio, and to take all actions necessary in order to complete said purchase and restore the site for future public use and purposes as determined from time to time.

SECTION 2: This ordinance shall take effect as an emergency measure. The reason for the emergency is that the prompt effectiveness of this measure is necessary in order to acquire the site at the most economical price possible, and to comply with the terms and conditions of the Seller who has listed the property for sale and desires a closing before July 10, 2014, and accordingly, expedited action is necessary in order to obtain the site for municipal purposes, said site being extremely desirable for park and other recreational uses by the citizens of the City. Without expedited action, the opportunity for acquisition of the site may be lost, being of great detriment to our citizens, and accordingly, in order to protect the public health, safety, and especially the well-being of our citizens and future citizens, it is necessary for this measure to be effective immediately upon passage in order to meet all contractual terms and obligations desired by the Seller.


