ORDINANCE AMENDING AND ADOPTING SECTION 31.01 OF THE CODIFIED ORDINANCES OF THE CITY OF BOWLING GREEN, OHIO, REGARDING REGULAR MEETINGS OF CITY COUNCIL

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BOWLING GREEN, COUNTY OF WOOD, AND STATE OF OHIO:

SECTION 1: That Section 31.01 of the Codified Ordinances of the City of Bowling Green, Ohio, is hereby amended and adopted to read as follows:

SECTION 31.01 REGULAR MEETINGS

Regular meetings shall be held in the Council Chamber on the first and third Monday of each month at such time as determined by City Council. When the date of any meeting falls on a legal holiday or an election day, Council shall meet on the following day at the same hour. Council may dispense with any regular meeting or change the day and hour of holding any regular meeting.
