
WHEREAS, representatives of the City of Bowling Green and representatives of the International Association of Firefighters, Local 2379, have negotiated a contract, and


WHEREAS, the International Association of Firefighters, Local 2379, has ratified said contract.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BOWLING GREEN, WOOD COUNTY, OHIO:

SECTION 1: The Municipal Administrator is hereby authorized to sign and enter into a contract with the International Association of Firefighters, Local 2379, said contract being on file in the Personnel Department of the City of Bowling Green, Ohio.


