The special meeting of the Bowling Green City Council, held in the Council Chamber, 304 North Church Street, Bowling Green, Ohio was called to order at 5:00 p.m. by Council President Aspacher. The meeting began with the Pledge of Allegiance.

On roll call, Council Members Aspacher, Gavarone, Gordon, Jeffers, McOmber, Rowland and Zanfardino responded. Also present were Mayor Richard Edwards, Municipal Administrator John Fawcett, Assistant Municipal Administrator Lori Tretter, and Public Works Director Brian Craft.

**READING OF LEGISLATION**

Clerk read Ordinance #8330 providing supplemental appropriations for the current expenses and other expenditures of the City of Bowling Green, Ohio, during the fiscal year beginning January 1, 2014 and ending December 31, 2014, for second reading.

Council Member McOmber moved, Jeffers seconded, to suspend the rules and give Ordinance #8330 its third reading. On roll call vote, Council Members Gavarone, Gordon, Jeffers, McOmber, Rowland, Zanfardino, and Aspacher voted yes. Council President Aspacher declared motion carried, and rules suspended.

Clerk read Ordinance #8330 for third reading by number and title only.

Council Member McOmber moved, Rowland seconded, to adopt Ordinance #8330. On roll call vote, Council Members Gordon, Jeffers, McOmber, Rowland, Zanfardino, Aspacher, and Gavarone voted yes. Council President Aspacher declared motion carried, and Ordinance #8330 adopted.

Clerk read Ordinance #8331 authorizing the Municipal Administrator to sign a contract with the International Association of Firefighters, Local 2379, and declaring an emergency, for second reading.

Council Member Gavarone moved, McOmber seconded, to suspend the rules and give Ordinance #8331 its third reading. On roll call vote, Council Members Jeffers, McOmber, Rowland, Zanfardino, Aspacher, Gavarone, and Gordon voted yes. Council President Aspacher declared motion carried, and rules suspended.


Clerk read Ordinance #8331 for third reading by number and title only.

Council Member Gavarone moved, Zanfardino seconded, to adopt Ordinance #8331. On roll call vote, Council Members Rowland, Zanfardino, Aspacher, Gavarone, Gordon, Jeffers, and McOmber voted yes. Council President Aspacher declared motion carried, and Ordinance #8331 adopted.

Council Member Rowland moved, Jeffers seconded, to adjourn. On unanimous voice vote, Council President Aspacher adjourned the May 28, 2014 special meeting of the City Council at 5:05 p.m., subject to call.
