ORDINANCE AMENDING AND ENACTING SECTION 33.04 OF THE CODIFIED ORDINANCES OF THE CITY OF BOWLING GREEN, OHIO RELATIVE TO PAY SCALES FOR SEASONAL EMPLOYEES

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BOWLING GREEN, OHIO:

SECTION 1: That Section 33.04 of the Codified Ordinances of the City of Bowling Green, Ohio is hereby amended and enacted to read as follows:

33.04 PAY SCALES ESTABLISHED FOR SEASONAL EMPLOYEES

Table with 3 columns: POSITION, BASIS, WAGE. Rows include Program Leaders, Safety Town, Concessions/Attendants, Aquatics Complex, and Carter Park Sports Complex.

* Lifeguards at the city pool who complete their terms of employment shall receive an hourly bonus of \$0.25 per hour. The bonus totals established will be based on gross earnings. Therefore, eligible employees shall receive their bonuses only after the correct payroll deductions have been taken for taxes and other necessary payroll deductions. The bonus payments will be included on each affected W-2 for the calendar year.

Table with 3 columns: POSITION, BASIS, WAGE. Rows include Carter Park Sports Complex, Officials, and Maintenance.

SECTION 2: All other existing portions of section 33.04 remain unchanged.

SECTION 3: This ordinance shall take effect as of January 1, 2014 in order to comply with state-mandated minimum wage laws.

ORDINANCE AMENDING AND ADOPTING SECTIONS 30.15, 30.52(I) & (J) AND 30.53(F) OF THE CODIFIED ORDINANCES OF THE CITY OF BOWLING GREEN, OHIO, FOR AN INCREASE FROM \$25,000 TO \$50,000 FOR CONTRACTING WITHOUT THE NECESSITY OF ADVERTISING TO COMPLY WITH THE OHIO REVISED CODE

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BOWLING GREEN, COUNTY OF WOOD, STATE OF OHIO:

SECTION 1: Section 30.15 is hereby adopted to read as follows:

SECTION 30.15 ADMINISTRATOR TO ENTER INTO CONTRACTS.

The Municipal Administrator is hereby authorized to enter into contracts for necessary City equipment and improvements not exceeding \$50,000.00. the Municipal Administrator shall obtain authorization from Council for any equipment or improvements exceeding \$50,000.00 and shall have the authority to advertise for all contracts involving more than \$50,000.00

SECTION 2: Sections 30.52(I), 30.52(J), and 30.53(F) are hereby amended to read as follows:

30.52 - DUTIES.

It shall be the duty of the Board of Public Utilities to:

- (I) Advertise for bids. Advertise for bids on all contracts involving more than \$50,000.00.
- (J) Obtain authorization. Obtain authorization from Council for any improvements, extension, or addition to municipal utility systems estimated to cost more than \$50,000.00.

30.53 - POWERS.

The Board of Public Utilities shall have the power to:

- (F) Make improvements. Make improvements and extensions costing in each instance not more than \$50,000.00, to the municipal electric, waterworks and sewer systems.

SECTION 3: This ordinance shall take effect on January 1, 2014.
