



ORDINANCE CERTIFYING UNPAID COST OF WEED MOWING TO THE COUNTY AUDITOR FOR PLACEMENT ON THE TAX DUPLICATE

WHEREAS, the Charter of the City of Bowling Green, Ohio, and Ohio Revised Code Section 701.05 grant assessment authority; and

WHEREAS, Codified Ordinances provide notification to property owners to mow weeds on premises within the City; and

WHEREAS, the property owners were notified to have weeds moved and failed to timely remove the same requiring the City to remove the same at the cost of the City; and

WHEREAS, the property owners upon demand have refused to reimburse the City of Bowling Green for the cost of such services;

WHEREAS, the Finance Director has certified such costs to the Council for certification to the Wood County Auditor to place on the tax duplicate.

ORDINANCE AUTHORIZING THE MUNICIPAL ADMINISTRATOR TO ADVERTISE FOR BIDS AND ENTER INTO A CONTRACT OR CONTRACTS AND/OR PARTICIPATE IN STATE AND/OR FEDERAL PURCHASING PROGRAMS FOR THE PURCHASE OF A K-9 VEHICLE FOR USE BY THE POLICE DIVISION, AND DECLARING AN EMERGENCY
