ORDINANCE AMENDING THE ZONING DISTRICT MAP OF THE CITY OF BOWLING GREEN, OHIO, FOR APPROXIMATELY 2.27 ACRES LOCATED ON NORTH ENTERPRISE STREET AND EAST WOOSTER STREET AND APPROXIMATELY 0.174 ACRES LOCATED AT 416-418 EAST COURT STREET FROM R-2 SINGLE FAMILY RESIDENTIAL AND B-2 GENERAL COMMERCIAL TO B-5 TRANSITIONAL CENTRAL BUSINESS DISTRICT ZONING CLASSIFICATION, AS PETITIONED FOR BY WESTRIDGE LANDING, LLC, ROBERT MAURER AND PAMELA KETZENBARGER

SECTION 1: That the Zoning District Map of the City of Bowling Green, Ohio is hereby amended so as to rezone approximately for approximately 2.27 acres located on North Enterprise Street and East Wooster Street and approximately 0.174 acres located at 416-418 East Court Street from R-2 Single Family Residential and B-2 General Commercial to B-5 Transitional Central Business District zoning classification, as petitioned for by Westridge Landing, LLC, Robert Maurer and Pamela Ketzenbarger in accordance with the map attached to and made a part hereof.
