A. First Reading

Ordinance establishing interim zoning of A-1 Agricultural for approximately 0.86 acres of land located at 14099 Mitchell Road, recently annexed as petitioned for by Douglas and Joyce Hinesman.

Ordinance amending the Zoning District Map of the City of Bowling Green, Ohio, for the properties generally known as 518-522 East Wooster Street from B-2 General Commercial to B-5 Transitional Central Business District zoning.

Ordinance amending and adopting Section 150.16 of the Codified Ordinances of the City of Bowling Green, Ohio, concerning maximum building height in the B-5 zoning classification from 25 feet to 35 feet.
