## ORDINANCE AMENDING AND ADOPTING SECTION 33.03(A) OF THE CODIFIED ORDINANCES OF THE CITY OF BOWLING GREEN, OHIO, RELATING TO PAY FOR SCHOOL POLICE, INTERNS, AND CIVIL INFRACTIONS HEARING OFFICER, AND DECLARING AN EMERGENCY

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BOWLING GREEN, WOOD COUNTY, OHIO:

SECTION 1: That Section 33.03(A) of the Codified Ordinances of the City of Bowling Green, Ohio, is hereby adopted to read as follows:

### SECTION 33.03 PAY SCALE ESTABLISHED FOR SCHOOL POLICE AND INTERNS, AND CIVIL INFRACTIONS HEARING OFFICER

- (A) School Police.
  - (1) \$12.43 for a morning crossing (start of school day) worked.
  - (2) \$12.43 for mid-day crossing worked (employees who cover mid-day crossings will be paid a maximum of \$12.43 regardless whether they cross children only at the end of the morning kindergarten session only at the start of the afternoon kindergarten session, or are required to cover both mid-day time periods).
  - (3) \$12.43 for afternoon crossing (end of school day) worked.

Employees working as School Police shall in no case be paid more than \$37.29 per day.

The crossing rates established above for School Police shall be effective August 1, 2018.

SECTION 2: This ordinance shall take effect as an emergency measure. The reason for the emergency is that it is essential that pay scales are in place in a timely fashion for the upcoming school year, thereby protecting the public peace, health, and safety of our citizens.
