**ORDINANCE AMENDING THE ZONING DISTRICT MAP OF THE CITY OF BOWLING GREEN, OHIO, FOR PROPERTY GENERALLY KNOWN AS 140 SOUTH GROVE STREET FROM S-3 PLANNED INSTITUTIONAL AND R-2 SINGLE FAMILY RESIDENTIAL TO I-1 INSTITUTIONAL ZONING**


