Resolution authorizing the Mayor of the City of Bowling Green, Ohio, to file a capital and operating plan for the years 2020 through 2023 with the Ohio Department of Transportation for grants through the U.S. Department of Transportation, as authorized under federal transit laws, as Codified, 49 USC Section 5311, Financial Assistance for Other Than Urbanized Areas.
