Ordinance No. 8866 Passed October 5, 2020

ORDINANCE ELIMINATING FUND NUMBERS 5226, 5336 AND 5338 AS NO LONGER NECESSARY FOR MUNICIPAL BUDGETING AND ACCOUNTING PURPOSES, REMOVING CHAPTER 53 OF THE CODIFIED ORDINANCES REGARDING GAS SERVICE, AND AMENDING AND ADOPTING SECTION 35.17 OF THE CODIFIED ORDINANCES OF THE CITY OF BOWLING GREEN, OHIO, REGARDING FUNDS

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BOWLING GREEN, COUNTY OF WOOD, STATE OF OHIO:

SECTION 1: That the following fund numbers are hereby eliminated as they are no longer necessary for municipal budgeting and accounting purposes:

- 5226 – Natural Gas Rotary Fund
• 5336 – Gas Rotary Fund
• 5338 – Underground Storage Tank Fund

SECTION 2: That Chapter 53 of the Codified Ordinances of the City of Bowling Green, Ohio, regarding gas service, is hereby removed as no longer needed for municipal purposes.

SECTION 3: That Section 35.17 of the Codified Ordinances of the City of Bowling Green, Ohio, is hereby amended and adopted as follows:

SECTION 35.17 UNDERGROUND STORAGE TANK (UST) GUARANTEE FUND

The Finance Director is hereby authorized and directed to establish the special revenue fund entitled "Underground Storage Tank (UST) Guarantee Fund" solely for the purpose of providing guarantee standby trust funds for the Wood County Regional Airport for compensating third parties for bodily injury and property damage caused by accidental releases arising from the operation of petroleum underground storage tanks if the Wood County Regional Airport Authority is unable to pay the deductible amount.

SECTION 4: This ordinance shall take effect at the earliest time permitted by law.

ORDINANCE AUTHORIZING THE MUNICIPAL ADMINISTRATOR TO SIGN A CONTRACT WITH THE BOWLING GREEN POLICE PATROLMAN'S ASSOCIATION OPBA, AND DECLARING AN EMERGENCY

WHEREAS, representatives of the City of Bowling Green and representatives of the Bowling Green Police Patrolman's Association OPBA, have negotiated a contract, and

WHEREAS, the Bowling Green Police Patrolman's Association OPBA, has ratified said contract;

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BOWLING GREEN, OHIO:

SECTION 1: The Municipal Administrator is hereby authorized to sign and enter into a contract with the Bowling Green Police Patrolman's Association OPBA, said contract being on file in the Personnel Department of the City of Bowling Green.

SECTION 2: This ordinance shall take effect as an emergency measure. The reason for the emergency is that the prompt implementation of said contract is necessary in order to maintain continuity with the Bowling Green Police Patrolman's Association OPBA, and in that manner protect the public health, safety, and welfare of our citizens.
