





RESOLUTION AUTHORIZING THE MAYOR OF THE CITY OF BOWLING GREEN, OHIO, TO ACCEPT A GRANT AND ENTER INTO A CAPITAL IMPROVEMENT PROJECT GRANT AGREEMENT WITH THE OHIO DEPARTMENT OF PUBLIC SAFETY FOR THE MARCS TOWER PROJECT

WHEREAS, pursuant to Am. Sub. Senate Bill No. 310 General Assembly, the State of Ohio has appropriated funds in the amount of \$500,000 for the City of Bowling Green (grantee), and

WHEREAS, the General Assembly has identified the Administrative Building Taxable Bond Fund as the fund from which these monies will be disbursed;

WHEREAS, the Ohio Department of Public Safety (ODPS) agrees to provisions and conditions set forth in the Capital Improvement Project Grant Agreement and will apply the grant funds to the MARCS tower project.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF BOWLING GREEN, COUNTY OF WOOD, STATE OF OHIO:

SECTION 1: That the Mayor of the City of Bowling Green, Ohio, is hereby authorized to sign the Capital Improvement Project Grant Agreement and other related documents and to provide such additional information as may be required.


