ORDINANCE AUTHORIZING THE MUNICIPAL ADMINISTRATOR TO SIGN AN LPA AGREEMENT WITH THE OHIO DEPARTMENT OF TRANSPORTATION (ODOT) AND TO ADVERTISE FOR BIDS AND ENTER INTO A CONTRACT OR CONTRACTS FOR DESIGN, ENGINEERING, RIGHT-OF-WAY ACQUISITION, CONSTRUCTION, AND OTHER SERVICES RELATING TO THE RESURFACING OF STATE ROUTE 64 IN BOWLING GREEN FROM CAMPBELL HILL ROAD TO THE CSX RAILROAD AND FROM N. CHURCH STREET TO THE BOWLING GREEN CORPORATION LINE

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BOWLING GREEN, COUNTY OF WOOD, AND STATE OF OHIO:

SECTION 1: That the Municipal Administrator is hereby authorized to sign an LPA Agreement with the Ohio Department of Transportation (ODOT) and to advertise for bids and enter into a contract or contracts for design, engineering, right-of-way acquisition, construction, and other services relating to the resurfacing of State Route 64 in Bowling Green from Campbell Hill Road to the CSX Railroad and from N. Church Street to the Bowling Green Corporation line.
