ORDINANCE AUTHORIZING THE MUNICIPAL ADMINISTRATOR TO ENTER INTO A CONTRACT WITH HULL & ASSOCIATES, INC. FOR DESIGN AND ENGINEERING AND TO ADVERTISE FOR BIDS AND ENTER INTO A CONTRACT OR CONTRACTS FOR THE CONSTRUCTION OF A MARCS COMMUNICATIONS TOWER

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BOWLING GREEN, STATE OF OHIO:


